EAB Update:

After meeting with Stan from Autumn Tree Care Experts, it is clear that the proposed method of treatment from the Care of Trees is not viable. Research is clear that it is not effective.

I have obtained a quote from ATCE for injections of Tree-age. The research is very promising. In several studies by MSU & OSU, a single injection of Tree-age provided excellent control of EAB for at least two years, even in high pest areas.

Stan has identified 19 trees that are good candidates for the injections. There are an additional 8 trees that he gave a 50/50 chance. An additional 11 trees are recommended for removal.

After presenting the above information to the board, a motion was made by Greg Van Zandt, with a second by Matt Vetter to proceed with the injections of Tree-age for the 19 trees recommended by ATCE and to remove the other 19 trees that were already dead or severely infected.
