2) Review / Approval of November 2021 Meeting Minutes - Carl True

3) Treasurer's Report - Jim Vielbig

a) Review of 2022 YTD SFPOA financials

Jim goes through budget details; 2 people didn't pay.

Discussion: check to Encap; the remaining expenditure was insurance.

Jim goes through remaining expenses. Landscaping list to be discussed.

Electronic payment: Yarko brought up the topic; the fees vary, and it's not worth it.

4) Landscaping and Maintenance - Ed Klosowski - Chair

- a) Common Areas
 - i) Northcreek project updates

Meeting in April to review work for the year w/ Encap. \$4,000 budgeted. There have been some communications issues. Office offered to change managers (we have to go after her, doesn't return emails, calls).

We'll see how this manager adjusts responsiveness.

ii) 2022 upcoming common area initiatives

(1) Sign painting

After the 5 entrance signs are stained this year, they most likely need to be replaced within 5 years. There are 3 more entrance signs to stain yet - two on Denker, and one at the main entrance on Silver Glen.

We will need to discuss, budget.

(2) Other items

Some fences may need mending (a bad one on Cutwood).

Pruning, we're owed a tree... a blue spruce.

W.r.t. streets, Ed plans on calling / talking w/ Village President (they are more involved than township). Ed wants a status for grant money for Denker (first for review). The

primary streets will be the first to get attention. The village has >90% of the township roads, which is why the village is managing the roads now.

iii) Tree protection - beaver issue

Jim goes over Keepn-It-Greener service agreement.

- we've worked 10 years w/ Efrain (owner of Keepn-It-Greener)
- this is 3rd 5 year contract
- Efrain's relationship w/ the SFPOA is a worthwhile relationship, so Jim talks about desire to protect him, since he protects, serves us well.

Carl: argues for Efrain vs. other bids, his match of size of work he looks for seems to be a good match for our HOA.
