4) Treasurer's Report - Jim Vielbig

a. Review of 2022 YTD SFPOA financials

4% over budget on landscaping, but within \$500 of budget. This includes unexpected tree we needed to take down. Efrain's (the Association's landscaper) new contract made this better. Other variances: professional fees - KSN is our law firm which we watched; accounting firm is what it always was (\$450). Encap project budget was \$2,500 over but we stayed within overall budget. We budgeted \$2,000 to put in reserve (on top of the \$9,142 currently in reserve), which we will be able to do. Landscaping and Insurance are big items.

a. Review 2022 activities

Planted two new trees and had one dead tree replaced under warranty. Yearend mowing accomplished.

b. Discuss 2023 needs/priorities/ideas

- i. Dead tree removal (association)? Ed walking through says nothing looks bad. We'll talk about contacting lot-owner dead trees to prepare people for cleaning up dead trees by May. Ed will get township to check whose responsibility the old oak on Cutwood is.
- ii. Walking path canopy trimming too much ducking and weaving needed to walk

Lower vegetation is Encap's focus. If there's some budget allowance to address upper canopy, we could address this. Ed will talk to Efrain (Association's landscaper).

iii. Walking path extension/additions Carl: we will schedule a walkthrough of path Lauren & Ed were talking about (re: place to cross the creek). Carl also wants to visit Denker Court and Silver Glen.
