 - i. White oak tree on Cutwood
 - 1. Any news from Campton Highway Dept? Campton deemed the tree to be safe (2 dead limbs). The trimming bid is \$1400.00.
 - ii. New updates

1. New village president (Barbara Wojnicki).

Village president has not returned call on roads meetings. Our Splitrail Subdivision roads have not been repaved in 20 plus years. They apparently have a 3rd party engineering study, and we're not on the top of the list. Looking at their meeting minutes, Denker is classified as a connector road, which will be eligible for a federal grant. Village Police Chief has been placed on paid leave. An Interim Chief is in place.

2. ENCAP completed 2 phases of 2023 spraying along North Creek Ed would like to have a different approach to contracts with ENCAP, have a phased approach - a bigger, bolder multi-year plan. Jim reports that Efrain has done a great job with trails, and canary grass (invasive) grass is still where ENCAP was working on -is this still something which is on ENCAP's plan?

3. Future

Ed would like to plant two sugar maples in the fall, at the end of Old Farm Lane where it joins Splitrail Ln, near Denker). Let's get a budget estimate for this year's budget.

a. Neighbor dead tree removal plan

Some still need to be done; a lot have been done. There are also a few new dead trees. The next step would be to send individual letters. We are not inclined to push people to do things, but we would like to have plans, that is letter of intent.

b. Entrance sign idea review (Emily and Lauren initial review) Jim took a trip to Batavia, and got samples. Foam covered with a hard material. Jim pounded it with a hammer, and it got no dents - a large sign

weigh what you would expect foam to weigh. Gave a list of 100 signs which have been done, and they look good. Yarko will measure current sign on Silver Glen, so we can submit for a budget starting point (it's the largest sign).

- c. North creek brush cleanup/burn fall/winter project due to dry weather
- **d.** South common area cherry tree (choke cherry) project
 While not invasive, they are detrimental since they grow so densely. In the short term, cut them down and spray the stumps. It will take only a few people, will plan on it in the next month or so.
